**PSYCHOPATHY** is a clinical construct defined by a cluster of personality traits and behaviors. Not surprisingly, psychopathy plays an important role in all aspects of criminal justice and mental health systems. Psychopathic individuals pose a serious challenge for those on the front-line of law-enforcement and mental health. The consequences of these encounters are always uncertain and sometimes quite dangerous.

### DR. ROBERT HARE



Dr. Robert Hare is Emeritus Professor of Psychology, University of British Columbia, where he has taught and conducted research for more than four decades, and President of Darkstone Research Group Ltd., a forensic research and consulting firm. Dr. Hare is author of "Without Conscience: The Disturbing World of the Psychopaths Among Us." He is considered the world's expert on psychopathy and developed the gold standard for the assessment of psychopathy, known as the PCL-R (Psychopathy Checklist Revised).

### DR. MATT LOGAN



Dr. Matt Logan completed his Ph.D. at the University of British Columbia while he was an active police officer. He was a member of the Royal Canadian Mounted Police for 28 years serving in five communities within British Columbia and a tour of duty in Ottawa and at the Federal Law Enforcement Training Center in Glynco, Georgia.

### DR. MARY ELLEN O'TOOLE



Dr. Mary Ellen O'Toole's law enforcement career spanned 32 years, beginning in the San Francisco's District Attorney's Office when she was a Criminal Investigator. Dr. O'Toole worked as an FBI agent for 28 years, spending more than half of her Bureau career in the organization's prestigious Behavioral Analysis Unit—that is the focus of the TV crime series "Criminal Minds."
